- The customer agrees to give one calendar month's notice to terminate this agreement, whereby any outstanding balance must be settled in full prior to departure. Should any refundable amount, such as a deposit, be on record this amount may be used to settle any outstanding balance(s) on the client's account with Store It SA - either at the discretion of Store It SA or agreed upon by both parties.
